

# Invitation for Bids

- Omsatiya Rural Municipality** has received a grant from GoN toward the cost of following bids and intends to apply part of the funds to cover eligible payment under the Contract for the **ORM/WORK/17/078/79**. Bidding is open to all eligible Nepalese Bidders.
- Omsatiya Rural Municipality electronic bids from eligible bidders for the **Construction of Patkhauli Secondary School Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
- Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [NRs 3,30,00,000.]
  - Minimum Work experience of similar size and nature: [number of project is 1 (one) and value of each project is NRs. 2,70,00,000.]
- Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically should deposit the cost (as specified in the table below) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - Pre-bid meeting shall be held **Omsatiya Rural Municipality, Rupandehi** at **2:00 PM on 2078-11-13**.
- Electronic bids must be submitted to the office **Omsatiya Rural Municipality** through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 Noon on 2078-11-25**. Bids received after this deadline will be rejected.
- The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm on 2078-11-25** at the office of **Omsatiya Rural Municipality, Rupandehi**. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 9,00,000.(Nine Lakhs only)** which shall be valid for 30 days beyond the validity period of the bid.
