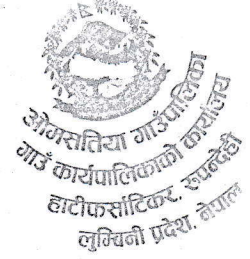

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 pm on 2080/10/23 (06 Feb ,2024)** at the office of **Omsatiya Rural Municipality, Rupandehi** .
