



6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 15-04-2025 13:00 at the office of Omsatiya Rural Municipality Rupandehi Lumbini Province Nepal.
Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of 45000, which shall be valid for 90 days beyond the validity period of the bid (i.e. [Refer Clause I TB 20.1]). If bid wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. [0400057764500047] at [NMB Bank Ltd. , Omsatiya - 1, Thutipipal, Rupandehi] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
