- The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on 2078/09/23 at the office of **Omsatiya Rural Municipality, Rupandehi**. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum (Amount is specified in the Table below) which shall be valid for 30 days beyond the validity period of the bid.
